

## LLB LAW (EUROPEAN LEGAL STUDIES) (M155)

*[For students entering before October 2006]*

Programme offered at: Durham.

Mode of study: this programme is available full-time.

### LEVEL 1 (Certificate)

Students who wish to pursue their studies in the Honours School of Law (European Legal Studies) must, at the end of Level 1:

- i. satisfy the examiners in the Preliminary Honours assessment for Honours in Law in accordance with the University's Core Regulations;
- ii apply to the Board of Studies in Law to be admitted into the Honours School in Law (European Legal Studies) and have their application approved by the Chairman or Chairwoman of the Board of Studies in Law.

+ By the end of Level 3 students must have taken AT LEAST ONE of the modules from List A, B or C marked with an ‡.

Students may take more than one module marked with a ‡. Students entering the programme in October 2004 and thereafter must pass at least one of these modules at 40%: the application of compensation for marks of 35-39% at Level 3 will be subject to this requirement.

This degree has been approved as a qualifying law degree by the Law Society and the Bar Council of England and Wales. In order to obtain full exemption for the purposes of legal professional qualifications, candidates must take the following modules: Public Law, Law of Obligations, Fundamentals of Land Law, Criminal Law, Trusts and Equity.

## LLB LAW (EUROPEAN LEGAL STUDIES) (M155)

Mode of study: this programme is available full-time.

### LEVEL 1 (Certificate)

Students who wish to pursue their studies at Level 2 in Law (European Legal Studies) must, at the end of Level 1:

- i. satisfy the examiners in the Preliminary Honours assessment for Honours in Law in accordance with the University's Core Regulations;
- ii. apply to the Board of Studies in Law to be admitted to Level 2 of Law (European Legal Studies) and have their application approved by the Chairman or Chairwoman of the Board of Studies in Law.
