MA International Studies (M1K607)

1. This programme is available at Durham City in a full-time (12 months) or part-time (24 months) mode of study.
2. Candidates whose first language is not English will normally be required to possess a recent English language test score of 7.0 in IELTS with no component lower than 6.5, or a score of 102 in the TOEFL IBT with no component lower than 25.
3. Candidates shall study and be assessed in the following modules:

5. Modules offered by another Board of Studies must be approved by the Board of Studies concerned and the Board of Studies in Government and International Affairs.
6. Total credits may exceed 180 by up to 5 if a 20-credit language module is taken. A language module of more than 20 credits may be taken only with the agreement of the Programme Director, and must be accommodated within the overall 180-credit limit.

7. With the agreement of the Programme Director, two 20-credit language modules may be taken, in which case total credits accrued will be 190.
8. Modules marked with a ~ must be passed at 50% or above; a mark of 40-49% cannot be compensated.
9. Modules marked with a * are not available during the 2014–15 academic year.
