Assessment, progression and award

8. Modules marked with a ~ must be passed at 40% or above for the award of an honours degree. A mark of 30 – 39% cannot be compensated.
9. Modules marked with a # must be at 40% or above in order to progress to the ordinary degree at the next Level.
10. A student registered for the BSc Health and Human Sciences programme who wishes to transfer to the MAnth Medical Anthropology (L605) and is suitably qualified to do so, in accordance with the Core Regulations, shall be permitted to transfer subject to the approval of the Director of Undergraduate Studies.
11. Modules marked with a * are not available in 2016-2017.
12. 10 credit modules can only be taken with corresponding 10 credit module in the subsequent term.

Year abroad

13. Students admitted to the BSc Health and Human Sciences (B991) are able to apply to transfer to the BSc Health and Human Sciences (with Year Abroad) programme (B992). Students undertaking the BSc Health and Human Sciences (with Year Abroad) (B992) programme will undertake an approved study placement in an overseas university taking a course of study chosen in consultation with the programme director and the host institution. During the year abroad students will be assessed at module level by the host University. Assessment does not

contribute to the marks used to determine the award of the degree but successful completion is required to qualify for the BSc Health and Human Sciences with Year Abroad.

14. Candidates wishing to transfer to the BSc Health and Human Sciences (with Year Abroad) (B992) must:
 - a. have successfully completed Level 1 of the BSc Health and Human Sciences (B991) and progressed to Level 2 of the honours or Ordinary programme, and;
 - b. during the first term of Level 2 study, apply to the Board of Studies in the Department of Anthropology to be admitted to the BSc Health and Human Sciences (with Year Abroad) (B992) and have their application approved by the Chair of the Board of Studies in the Department of Anthropology, and;
 - c. successfully complete Level 2 of the BSc Health and Human Sciences (B991) so as to be eligible to progress to Level 3 of the BSc Health and Human Sciences (B991) Honours programme.
15. Students who the Board of Examiners for the Department of Anthropology deem to have made satisfactory progress on the year abroad will continue to Level 3 of the BSc Health and Human Sciences (with Year Abroad) (B992). Students who have not made satisfactory progress on the year abroad will not be permitted to continue on the BSc Health and Human Sciences (with Year Abroad) (B992) programme, but must instead proceed to Level 3 of the BSc Health and Human Sciences (B991) programme.
16. Students on the Erasmus programme who spend only one term at the host University must take modules (some or all of which can be modules specifically designated for returning Erasmus students) to the value of 40 credits from List C, alongside the 40 credit dissertation module [ANTH3162](#).
