Year 3 (Year Abroad)

During the third year of study students must undertake a period of residence in France and must study 40 credits from those modules offered on the 'licence sciences economique' (3rd year modules), those designed for students who specialise in either 'Economie Internationale' or 'Economie et Gestion de l'entreprise' at the University of Aix-Marseilles II. Students should achieve a minimum of 40 ECTS credits to pass the year.

11. Students who the Board of Examiners for the Business School deem to have made satisfactory progress on the Year Abroad will continue to Level 4 of the BA Economics with French (L1R1). Students who have not made satisfactory progress on the year abroad will not be permitted to continue on BA Economics with French (L1R1), but must instead proceed to Level 3 of the BA Economics (L100) programme.
