### **Year abroad**

17. Students admitted to the BSc Health and Human Sciences (B991) are able to apply to transfer to the BSc Health and Human Sciences (with Year Abroad) programme (B992). Students undertaking the BSc Health and Human Sciences (with Year Abroad) (B992) programme will undertake an approved study placement in an overseas university taking a course of study chosen in consultation with the programme director and the host institution. During the year abroad students will be assessed at module level by the host University. Assessment does not contribute to the marks used to determine the award of the degree but successful completion is required to qualify for the BSc Health and Human Sciences with Year Abroad.
18. Candidates wishing to transfer to the BSc Health and Human Sciences (with Year Abroad) (B992) must:
- have successfully completed Level 1 of the BSc Health and Human Sciences (B991) and progressed to Level 2 of the honours or Ordinary programme, and;
  - during the first term of Level 2 study, apply to the Board of Studies in the Department of Anthropology to be admitted to the BSc Health and Human Sciences (with Year Abroad) (B992) and have their application approved by the Chair of the Board of Studies in the Department of Anthropology, and;
  - successfully complete Level 2 of the BSc Health and Human Sciences (B991) so as to be eligible to progress to Level 3 of the BSc Health and Human Sciences (B991) Honours programme.
19. Students who the Board of Examiners for the Department of Anthropology deem to have made satisfactory progress on the year abroad will continue to Level 3 of the BSc Health and Human Sciences (with Year Abroad) (B992). Students who have not made satisfactory progress on the year abroad will not be permitted to continue on the BSc Health and Human Sciences (with Year Abroad) (B992) programme, but must instead proceed to Level 3 of the BSc Health and Human Sciences (B991) programme.
