#### Assessment, progression and award

- 12. Students who have successfully completed the first two Levels of the Master of Chemistry F105 in accordance with the Core Regulations may, with the permission of the Chair of the Board of Studies in Chemistry, change their registration to the Master of Chemistry (International Route) F102 or Master of Chemistry (Industrial Route) F111.
- 13. Students who fail to achieve the standard required under the Core Regulations for progression to Level 3 of the MChem but who achieve the standard required for progression to Level 3 of a Bachelors programme may progress to Level 3 of the BSc Chemistry in the Honours or Ordinary stream in accordance with the Core Regulations
- 14. A student who is qualified to progress from Level 2 to Level 3 of the MChem but wishes to transfer to Level 3 of the BSc Chemistry shall be permitted to do so.
- 15. Students whose achievement at the end of Level 3 does not qualify them to proceed to Level 4 may be awarded the degree of Bachelor of Chemistry (BChem) at either Honours or Ordinary level in accordance with the Core Regulations for the award of a Bachelors degree.
- 16. Modules marked with a ~ must be passed at 40% or above in order to progress to the next Level of study. A mark of 30-39% cannot be compensated.
- 17. Modules marked with a # must be passed at 40% or above in order to progress to the Ordinary degree at the next Level.
- 18. Students whose achievement at the end of Level 4 does not qualify them to be awarded the degree of MChem may be awarded the degree of Bachelor of Chemistry (BChem) with Honours in accordance with the Core Regulations for the award of a Bachelors degree.

#### **Professional accreditation**

19. This programme is accredited by the Royal Society of Chemistry for students entering Level 1 up to and including October 2023 as satisfying the academic requirements for the award of Chartered Chemist (CChem) for holders of first or second class honours degrees.
