Assessment, progression and award

- 8. Modules marked with a # must be passed at 40% or above in order to progress to the ordinary degree at the next Level.

Professional accreditation

10. Durham University Business School is accredited by the European Quality Improvement System (EQUIS) for a period of five years from 2017 and by the Association to Advance Collegiate Schools of Business (AACSB) for a period of five years from 2019.

Year 3 (Placement Year / Study Abroad)

- Students admitted to the BA Economics (L100) are able to apply to transfer to the BA Economics (with Placement Year) programme (L106) or the BA Economics (with Study Abroad) programme (L109).
- 12. Candidates wishing to transfer to the BA Economics (with Placement Year) (L106) or the BA Economics (with Study Abroad) (L109) must:
 - a. have successfully completed Level 1 of the BA Economics (L100) and progressed to Level 2 of the honours or Ordinary programme, and;
 - b. during the first term of Level 2 study, apply to the Board of Studies in the Business School to be admitted to the BA Economics (with Placement Year) (L106) or the BA Economics (with Study Abroad) (L109) and have their application approved by the Chair of the Board of Studies in the Business School; and
 - c. successfully complete Level 2 of the BA Economics (L100) so as to be eligible to progress to Level 3 of the BA Economics (L100) Honours programme.

Placement Year

- 13. Students will undertake an approved work placement or work placements of not less than 40 weeks in total (or not less than 24 weeks in total in 2020/21). They must have successfully completed 240 credits at Levels 1 and 2 to progress to the placement. Student progress will be assessed at threshold level by continuous assessments of the student's performance during the placement and a final report. Assessment does not contribute to the marks used to determine the award of degree but successful completion is required to qualify for the BA Economics with Placement Year.
- 14. Students who the Board of Examiners for the Business School deem to have made satisfactory progress on the Placement Year will continue to Level 3 of the BA Economics (with Placement Year) (L106). Students who have not made satisfactory progress on the year abroad will not be permitted to continue on BA Economics (with Placement Year) (L106), but must instead proceed to Level 3 of the BA Economics (L100) programme.

Study Abroad

- 15. Students will undertake an approved study placement in an overseas university. Student progress will be assessed at module level by the host University. Assessment does not contribute to the marks used to determine the award of degree but successful completion is required to qualify for the BA Economics with Study Abroad. Students should pass a minimum of 40 ECTS credits, or equivalent, to successfully complete the year, as set out in their Learning Agreement.
- 16. Students who the Board of Examiners for the Business School deem to have made satisfactory progress on the year abroad will continue to Level 3 of the BA Economics (with Study Abroad) (L109). Students who have not made satisfactory progress on the year abroad will not be permitted to continue on BA Economics (with Study Abroad) (L109), but must instead proceed to Level 3 of the BA Economics (L100) programme.
