During the third year of study students must undertake a period of residence in France and must study 40 credits from those modules offered on the 'licence sciences economique' (3rd year modules), those designed for students who specialise in either 'Economie Internationale' or 'Economie et Gestion de l'enterprise' at the University of Aix-Marseilles II. Students should pass a minimum of 40 ECTS credits to successfully complete the year.

- 9. Modules marked with a ~ must be passed at 40% or above for the award of an honours degree. A mark of 30 39% cannot be compensated.
- 10. Students who the Board of Examiners for the Business School deem to have made satisfactory progress on the Year Abroad will continue to Level 3 of the BA Economics with French (L1R1). Students who have not made satisfactory progress on the year abroad will not be permitted to continue on BA Economics with French (L1R1), but must instead proceed to Level 3 of the BA Economics (L100) programme.
- 11. Modules marked with a * are not available in 2022/2023.
- 12. In line with the <u>Core Regulations for Undergraduate Programmes</u>, where undergraduate modules are delivered entirely in a single term, students undertaking such modules should be permitted to take no more than 70 credits in total in a single term.
- Modules marked with a < will be delivered in Term 1, while modules marked with a > will be delivered in Term 2;
