1. This programme is available at Durham City, in a full-time mode of study. The lead department is Economics.

### **Level 2 (Diploma)**

Candidates shall study and be assessed in the following modules, noting that:

They should take no fewer than 40 credits and no more than 160 credits in each of the three disciplines at Levels 2 and 3, taken together, including at least one module marked %.

They must take a minimum of two modules in Philosophy at Level 2 if they wish to take PHIL 3112 Dissertation in Philosophy at Level 3.

They must take SGIA 2341 Research Project at Level 2 if they wish to take SGIA 3142 Dissertation in Politics at Level 3.

They must take ECON 2061 Economic Data Analysis at Level 2 if they wish to take ECON 3012 Dissertation in Economics at Level 3.

### Assessment, progression and award

2. Modules marked with a # must be passed at 40% or above in order to progress to the Ordinary stream at the next level.
3. Modules marked with a \* are not available in 2022/23.
4. In line with the Core Regulations for Undergraduate Programmes, where undergraduate modules are delivered entirely in a single term, students undertaking such modules should be permitted to take no more than 70 credits in total in a single term.
5. Modules marked with ~ must be passed at 40% or above. A mark of 30-39% cannot be compensated.
6. Candidates must take at least one module marked % at either Level 2 or Level 3.

### Year 3 (Placement Year / Study Abroad)

7. Students admitted to the BA Philosophy, Politics and Economics (VL52) are able to apply to transfer to the BA Philosophy, Politics and Economics (with Placement Year) programme (VLL6) or the BA Philosophy, Politics and Economics (with Study Abroad) programme (VLLA).
8. Candidates wishing to transfer to the BA Philosophy, Politics and Economics (with Placement Year) (VLL6) or the BA Philosophy, Politics and Economics (with Study Abroad) (VLLA) must:
  - a. have successfully completed Level 1 of the BA Philosophy, Politics and Economics (VL52) and progressed to Level 2 of the honours or Ordinary programme, and;
  - b. during the first term of Level 2 study, apply to the PPE Programme Director in the Business School to be admitted to the BA Philosophy, Politics and Economics (with Placement Year) (VLL6) or the BA Philosophy, Politics and Economics (with Study Abroad) (VLLA) and have their application approved by the PPE Programme Director in the Business School; and
  - c. successfully complete Level 2 of the BA Philosophy, Politics and Economics (VL52) so as to be eligible to progress to Level 3 of the BA Philosophy, Politics and Economics (VL52) Honours programme.

### Placement Year

9. Students will undertake an approved work placement or work placements of not less than 40 weeks in total (or not less than 24 weeks in total in 2020/21). They must have successfully completed 240 credits at Levels 1 and 2 to progress to the placement. Student progress will be assessed at threshold level by continuous assessments of the student's performance during the placement and a final report. Assessment does not contribute to the marks used to determine the award of degree but successful completion is required to qualify for the BA Philosophy, Politics and Economics with Placement Year.
10. Students who the Board of Examiners for the Business School deem to have made satisfactory progress on the Placement Year will continue to Level 3 of the BA Philosophy, Politics and Economics (with Placement Year) (VLL6). Students who have not made satisfactory progress on the Placement Year will not be permitted to continue on BA Philosophy, Politics and Economics (with Placement Year) (VLL6), but must instead proceed to Level 3 of the BA Philosophy, Politics and Economics (VL52) programme.

### Study Abroad

11. Students will undertake an approved study placement in an overseas university. Student progress will be assessed at module level by the host University. Assessment does not contribute to the marks used to determine the award of degree but successful completion is required to qualify for the BA Philosophy, Politics and Economics with Study Abroad. Students should pass a minimum of 40 ECTS credits, or equivalent, to successfully complete the year, as set out in their Learning Agreement.
  
12. Students who the Board of Examiners for the Business School deem to have made satisfactory progress on the year abroad will continue to Level 3 of the BA Philosophy, Politics and Economics (with Study Abroad) (VLLA). Students who have not made satisfactory progress on the year abroad will not be permitted to continue on BA Philosophy, Politics and Economics (with Study Abroad) (VLLA), but must instead proceed to Level 3 of the BA Philosophy, Politics and Economics (VL52) programme.

### **Access to Philosophy Modules**

13. The Department of Philosophy has agreed an exemption for PPE students with respect to the requirement that students registering for any particular Philosophy module, at either Level 2 or Level 3, must register for at least one other Philosophy module at the relevant level. This exemption applies only to all current students who commenced their programme of study prior to 2022/23.
