Assessment, progression and award

- 11. Modules marked with a # must be passed at 40% or above in order to progress to the next level of study.
- 12. Modules marked with a ~ must be passed at 40% or above for the award of an honours degree. A mark of 30 39% cannot be compensated.
- 13. Modules marked with a < will be delivered in Term 1, while modules marked with a > will be delivered in Term 2. To comply with the Core Regulations for Undergraduate Programmes, candidates may take no more than 70 credits in total in a single term.
- 14. Modules marked with a * are not available in 2025/26.
- 15. Candidates who commenced their programme of study before 2022/2023 are allowed to drop one discipline at Level 3, as long as they have studied 40 credits in that discipline at Level 2.
- 16. Candidates who commenced their programme of study before 2022/2023 are allowed to take 20 credits from List F (Philosophy) at Level 3 as a substitute for 20 credits from List I (Philosophy), subject to timetable compatibility.

Professional accreditation

17. Durham University Business School is accredited by the European Quality Improvement System (EQUIS) for a period of five years from 2022 and by the Association to Advance Collegiate Schools of Business (AACSB) for a period of five years from 2024.

Year 3 (Placement Year / Study Abroad)

18. Students admitted to the BA Philosophy, Politics and Economics (VL52) are able to apply to transfer to the BA Philosophy, Politics and Economics (with Placement Year) programme (VLL6) or the BA Philosophy, Politics and Economics (with Study Abroad) programme (VLLA).

- 19. Candidates wishing to transfer to the BA Philosophy, Politics and Economics (with Placement Year) (VLL6) or the BA Philosophy, Politics and Economics (with Study Abroad) (VLLA) must:
 - a. have successfully completed Level 1 of the BA Philosophy, Politics and Economics (VL52) and progressed to Level 2 of the programme, and;
 - during the first term of Level 2 study, apply to the PPE Programme Director to be admitted to the BA Philosophy, Politics and Economics (with Placement Year) (VLL6) or the BA Philosophy, Politics and Economics (with Study Abroad) (VLLA) and have their application approved by the PPE Programme Director; and;
 - c. successfully complete Level 2 of the BA Philosophy, Politics and Economics (VL52) so as to be eligible to progress to Level 3 of the BA Philosophy, Politics and Economics (VL52) Honours programme.

Placement Year

- 20. Students will undertake an approved work placement or work placements of not less than 40 weeks in total. They must have successfully completed 240 credits at Levels 1 and 2 to progress to the placement. Student progress will be assessed at threshold level by continuous assessments of the student's performance during the placement and a final report. Assessment does not contribute to the marks used to determine the award of degree but successful completion is required to qualify for the BA Philosophy, Politics and Economics with Placement Year.
- 21. Students who the Board of Examiners for the Business School deem to have made satisfactory progress on the Placement Year will continue to Level 3 of the BA Philosophy, Politics and Economics (with Placement Year) (VLL6). Students who have not made satisfactory progress on the Placement Year will not be permitted to continue on BA Philosophy, Politics and Economics (with Placement Year) (VLL6), but must instead proceed to Level 3 of the BA Philosophy, Politics and Economics (VL52) programme.

Study Abroad

- 22. Students will undertake an approved study placement in an overseas university. Student progress will be assessed at module level by the host University. Assessment does not contribute to the marks used to determine the award of degree but successful completion is required to qualify for the BA Philosophy, Politics and Economics with Study Abroad. Students should pass a minimum of 40 ECTS credits, or equivalent, to successfully complete the year, as set out in their Learning Agreement.
- 23. Students who the Board of Examiners for the Business School deem to have made satisfactory progress on the year abroad will continue to Level 3 of the BA Philosophy, Politics and Economics (with Study Abroad) (VLLA). Students who have not made satisfactory progress on the year abroad will not be permitted to continue on BA Philosophy, Politics and Economics (with Study Abroad) (VLLA), but must instead proceed to Level 3 of the BA Philosophy, Politics and Economics (VL52) programme.
